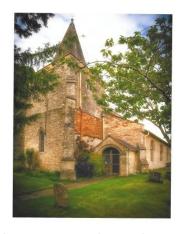

The Astwell Benefice

Financial Statement Report for the year ending December 2023

During 2023 the Benefice paid £62,497.30 to the diocese as our Parish Share. This is 90% of our full share. Most parishes either matched their 2022 contribution or exceeded it. We need to work hard to pay our full parish share in 2024.

Other costs were paid in full funded by £6508.50 from Wedding & Funeral fees, £6,064 from Benefice Fundraising, £1248 from the Rogation.

The balance in the books at the end of the year was £6,177, of this £447 is ring fenced for the choir; we are awaiting a final payment from the Diocese of £467 for services during the interregnum.

We have agreed a Benefice budget of £14,100. This covers secretarial pay, organist, and mission and ministry costs and includes £5,000 towards the share.

Helmdon and Radstone's Financial Statement Report for the year ending December 2023

The closing balance at the end of 2023 was £8,747. Of this £247 is from the Christingle collection and due to be paid to the Children's Society. Restricted funds were £4,729 for the churchyard and donations for the Organ and Children's Church fund (currently standing at £3,893).

During 2022 Helmdon paid the sum of £22,000 and Radstone £500 towards the Diocesan Share. Another £200 was paid directly to the Benefice and allocated to us. In total £22,700 constituted 96% of Helmdon and Radstone's Share allocation, an increase on the previous year.

During the year Radstone's separate bank account was closed and £145 transferred to Helmdon's account. This, together with collections from two services held in Radstone, resulted in a total income of £372. At the year-end a total £483 was being held in Helmdon's accounts for Radstone.

Donations received included those from the Friends of St Mary Magdalen, including covering roof repairs and a generous contribution to improvements to the sound system. The Parish Council also contributed a grant of £250 to the sound system improvement. Regular giving was £14,580, with collections and wall box contributing a further £3,963. Over £4,600 was raised during the year through a variety of activities including a jazz evening, Summer Fete, and Christmas Fair. A Diocesan grant received the previous year made a substantial contribution towards energy costs.

£1,880 was donated to charity, primarily reflecting donations from a memorial service held at the end of the previous year and to British Legion from collections made on Remembrance Sunday.

LOIS WEEDON PAROCHIAL CHURCH COUNCIL FINANCIAL REPORT FOR THE YEAR ENDING DECEMBER 2023

Commentary

As at the 31st December 2023, our total cash reserves stood at £8,836, divided between restricted funds of £6,490 and unrestricted funds of £2,346.

Total income year-on-year has fallen by £1,400. However, within our income total is an exceptional one-off amount of £1,750 from a grant provided to us by **Benefact Trust** towards the restoration and repair of the Chancel Window. Therefore, in real terms, our year-on-year income has fallen by £3,150.

Fund raising events in 2023 were once again curtailed by the increasing cases of COVID within our community which unfortunately led to the cancellation of the harvest supper. However, in April 2023, we successfully launched the monthly Coffee Morning event held at the Village Hall which singularly provided £2,173 to our funds. Thank you to all those volunteers that gave up their time and energy to provide all the delicious treats and of course, to all those that attended the event. It has proven to be very popular.

Income from Regular Giving and Service Collections has overall remained relatively stable when compared to the previous year.

Donations are significantly down on the previous year by more than £2,100.

Total expenditure year on year increased from £13,667 in 2022 to £16,042 in 2023 – an increase of 17.5%.

Much of that increase is accounted for by the costs (so far) to fix the Chancel window and the cost of a required electrical inspection and resulting repairs. In all, £5,901.64 has been spent on these items alone. However, we have been able to recover £983.73 from the Listed Places of Worship Grant Scheme to offset some of the costs.

Notwithstanding the reduction in our income and the increase in costs, we were able to support Astwell Benefice with a contribution of £4,918.

Chancel Window

In November 2022, a large crack was discovered above the Chancel Window and urgent temporary repairs were carried out in early January 2023.

Subsequently, professional services were procured to investigate the crack and it is estimated that the total costs to fully repair the Chancel Window will be in the region of £16,850 (including a £1,500 contingency).

We have applied to 4 grant providers to help with the costs and one, **Benefact Trust**, has generously provided a grant of £1,750. We await imminent responses from the remaining 3 providers. In addition, the Friends of St Mary & St Peter have generously committed to providing at least 50% towards the physical building repair costs.

We have so far expended £3,731.44 from our own reserves and recovered £621.91 as part of the monies received from the Listed Places of Worship Grant Scheme. A further £2,000 has been set aside from our reserves and currently, we anticipate a funding shortfall of circa £3,400 which we hope will be easily satisfied by the remaining 3 grant applications.

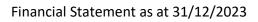
It is hoped that all work on the repair (which cannot proceed until we hear from all grant providers) will be completed in Q1 2023

FINANCIAL STATEMENT REPORT FOR THE YEAR ENDING

DECEMBER 2023

INCOME

Our Regular Giving decreased this year, however collections and donations increased.

We managed to hold fundraising events on both the hottest and coldest days of the year raising just £2062 of the £3000 hoped for.

We received donations from the Madge Payne Trust Fund, The Friends of St James and the Parish council to pay for maintenance works in the church and churchyards.

Our Steeple fund has so far received £5414 plus £5233 carried forward. We also have pledges of a further £19,000. We are further grant applications will be successful to help us repay a loan. We are still looking for £5000 to meet the full cost but could manage this from reserves if necessary.

EXPENDITURE

A total of £13,415 paid of our Parish Share, an increase on last year but still short of our full target.

We have spent a huge amount, £32,122, on Fabric this year, this includes £12,000 on our Sound System and £18,700 on Quinquennial works.

Charitable donations were made to the amount of £825, from Harvest, collections for DEC Disasters , Remembrance and Christingle Services

BALANCE

Our general spending balance at the end of 2023 was £2006 with £8955 reserved for the Steeple (some architects fees have been paid already) £4081 for other Quinquennial works and £4853 to cover maintenance work in 2024.

Income

2023 fundraising incomes were similar to the previous year. The Fete, on a very hot day in September, raised over £1200, with another successful dog show raising £340. We received £1,000 into the fabric fund from the Wappenham Beer & Music Festival committee in June for which we are very grateful. Regular giving remains similar to the previous year, but lower Church service collections reflect the lack of weddings and other extraordinary services. Gift aid receipts reflect the previous year's donations.

Expenditure

We had little capital expenditure in the year; new south doors, and other small improvements. We purchased a new ride on mower for the churchyard donated by a parishioner who is deferring their regular contribution in lieu of the cost of this large capital expense to assist in our cash flow. Infrastructure works have been delayed but will rise next year as we embark further on addressing issues raised by the Quinquennial inspection, the south roof which needs replacing, and some long overdue work to the churchyard. We are in discussion with the Parish Council in regard to the responsibilities of the churchyard which we hope will assist in a reduction of costs in the future.

Charitable Giving

We were able to send a total of £1,157.65 in support of the following charities:

Children's Society, Cancer Research, Ripple Effect (Send a Cow) & Royal British Legion, Northampton Hope centre, Wappenham Village Hall, MacMillan and SSNAP

2. Benefice Committee Reports for year ending December 2023

2.1 Benefice Finance Committee Summary 2023

The Finance Committee met in June, December and January. Agreements on the APCM contents were done by email during March.

During meetings we shared the financial positions, highs and lows of each parish, discussing fundraising, regular giving, collections and extraordinary expenses that face us all. We reported to the BPCC at each of their meetings. We acknowledged that the regular giving in most parishes is in need of increasing, in some parishes it is just very low and in others over reliant on a few givers. We plan to write letters to different groups of our parishioners, as suits each parish.

We ensured that all the benefice and parish accounts were prepared for examination in January. All quarterly returns and parish share contributions were submitted to the diocese in a timely fashion. All finance parish returns for 2023 were completed.

We were able to pay 90% of our parish share this year and are very grateful for the fundraising committee for their contribution to the Benefice payments. Sadly our contribution was down on this year. We aim to pay the full amount of £71,599 in 2024.

There are those who step forward to lead worship; Alice Palmer, Michael Streten, Bill Elkington, the team in Wappenham and Wiggy (despite "retiring"). These are, if you like, the obvious ones. But I should also like to thank everyone who contributes to the life of the benefice and parishes. Whether you clean, organise rotas, arrange flowers, make coffee, read lessons, lead prayers, sort out music, play the organ, sing in the choir, ring the bells or whatever...thank you! Without you our services simply could not happen.

The challenges faced by the benefice remain much as I reported last year and are pretty common across the Church of England. There is a need to continuously challenge ourselves on how we engage with the rural communities we serve, whilst continuing to support our existing congregations.

The past year was spent very much holding the fort and looking forward to our new Rector. No doubt Hugh will begin to shape how we move forward together as a united benefice.

Helmdon Church Council Report

Fundraising during the year

Our first event of the year was a Pancake Breakfast on 18 February. This proved popular, but the steep rise in ingredients' costs from previous years had a marked impact on money raised. A very enjoyable Church Fete at Fountain House on 1 July raised some £2,400. We were very grateful to the Crabbe family for allowing use of their lovely garden and for joining in so enthusiastically before, during and after the event. A wide range of stalls, teas, cakes, and other refreshments were on offer, with Morris Men, a local rock band and children's games (with a Fancy Dress Competition on the theme of "Coronation") providing entertainment.

On 2 September we had an excellent evening of trad jazz in the church with drinks and nibbles: £560 was raised.

The Christmas Fair on 2 December proved very successful and it was good to see some new faces helping with Santa's Grotto as well as the stalls and refreshments. This was followed by Carol Singing outside the pub shortly before Christmas, raising money for the Children's Society.

Fundraising for the year exceeded 2022 amounts by over £1,000, which helped offset falls in regular giving and collection levels. Helmdon and Radstone met 96% of their contribution to the Benefice parish share.

Friends also organised a very enjoyable Safari Supper for 46 people on 17June, involving hosts at various locations throughout the village, and raising over £630 for the Friends' funds. Which paid for our replacement amplifier and microphone coverage for the whole church. Many thanks to our friends association.

Church council meetings were held on 25 January, 27 March, 22 May, 21 August, 18 September and 13 November and are summarised below.

a) Finance

Ann Netten issued our full year accounts in the new format used by all churches. There were no comments and unanimously voted to send to our auditor.

b) Interregnum

After Rev Diane's resignation in 2022 due to ill health and following a meeting with Archdeacon Richard we agreed to get the benefice profile ready for that December. Due to changes and waiting agreement with all churches, this was not achieved until the spring. Rev Hugh was interviewed in August and to our joy accepted our offer of Rector to this benefice. His installation was in December 2023 another long interregnum.

c) Worship

Paul Stothard chaired this committee during the interregnum and noted that our committee was outside the worship benefice structure and we were the only church to have this. It was decided to include worship within the church council meetings. We tried a new expression service on the Saturday night before our harvest festival. This was attended by young families with Prosecco afterwards and a great success, will be repeated in 2024.

We thank all our retired clergy and Paul with lay leaders who kept us going through the year.

d) Pastoral Care

A benefice committee chaired by Wiggy in Helmdon. Tea parties were held in Whitfield, Syresham and Helmdon together with some home communions. Wappenham are still not covered in this committee and is still a problem.

e) Safeguarding

All up to date with DBS checks and training where required.

f) Fabric

We had a very good Quinquennial Inspection with very few No1 actions which have all been dealt with. Bill has completed the online course on the new faculty system which is much easier than the old system. The biggest item that we need to sort before the Autumn is the footpath to the church as it is classed as dangerous.

Friends of Helmdon Church

Helmdon 200 Club generously supports The Friends by providing us with £1300 annually. The highlight of the Friends' year was the brilliant Safari Supper held on 17 June. Angela Goodall's superb organisation, supported by the Friends' Committee Members on the practical side made this a hugely enjoyable event. 46 people undertook a culinary tour of the village for the three-course meal, and we made a net profit of £637. It also gave participants the chance to meet some incomers to the village as well as catch up with people who have lived in Helmdon for some time.

The Friends were very grateful to all the hosts for generously inviting groups of guests into their homes, and for some wonderful cooking on the day.

The Friends of Helmdon Church have continued to support the Helmdon Church Council when maintenance and repair costs have arisen. We have funded some repairs to the Lady Chapel roof area and repairs to the main church roof (which were spotted as necessary during the Quinquennial Inspection carried out in August and revealed by a rainwater leak some weeks later).

In total, we have paid almost £4800 to the Church Council in the calendar year 2023. Consideration is being given to converting a loan of £3,200 towards an upgrade of the church sound system, making it more reliable, into a grant. This is dependent on estimates of costs for works arising from the Quinquennial Inspection. One of these is for a major improvement to the main path into church. Clarification is being sought by the Churchwardens from Diocesan authorities for any necessary formal permission.

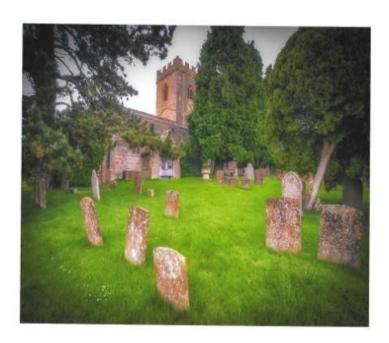

Churchwarden Report to the Astwell Benefice

1. Parish Status

2023 saw us once again without a Parish Priest. Unlike previously we have consolidated our Benefice Structure and were in good shape to weather the choppy seas.

The constant pressure on fundraising remains and we continue to rely upon our loyal supporters who as I observed last year, are not getting any younger or greater in number. With these challenges this last year has if anything seen a slight decline in our position in Lois Weedon. Despite our best efforts our contribution to the Benefice share did not improve and we fell a little in the league table.

Perusal of our accounts show a significant reduction year on year in regular revenue in our Operating (unrestricted) account from £12,800 to £11,240. Our Restoration & Fabric (Restricted) shows a minor increase in revenue from £2,713 to £2,876, due to exceptional items including a grant received and a VAT reclaim, together totalling £2,372, in respect of the east window repairs. Overall, our total assets (cash balances) reduced from £10,762 to £8,836, £6,490 0f which is held in our restricted account. Our target Parish Share was again beyond our financial capability in 2023, but we always strive to make the fullest contribution from our limited financial resources.

Our beloved local Primary School has been through a testing time in the last few years. Pupil numbers have declined for a variety of reasons, not least because of the reduction of children being born in our catchment area. As a member of the Evolve Academy Trust there is a measure of support but despite all challenges it is still the wonderful school it always was. Their Nativity Play took place in the School Hall (a warmer and more comfortable venue than the Church) which enabled all the children to take part in a most memorable afternoon.

We in Lois Weedon have the benefit of the Rector's accommodation although your Churchwarden doesn't need another house to look after. Its improved condition was a significant

asset in attracting our new incumbent although the size of the garden may prove somewhat daunting. As a Benefice we may have to help and urgently

During the Interregnum we managed to hold 27 standard services. We restricted ourselves to Holy Communion and Matins/Morning Prayer. Surprisingly our average attendance improved from 12 to 16 which goes against the trend. We had 3 funerals and one delightful and heartwarming Baptism.

The forecast for 2024 is looking more promising. Both Wappenham and ourselves are now benefitting from a donation from Tove Valley Broadband. We also have a well-established Coffee and cake morning which is proving to be a popular community event. Just a few more regular givers and I hope we will stand our corner in the future.

And finally we welcomed our new Rector to our community. Early on it was clear we had in our midst someone who relished interaction with all of his Parishioners. Christmas certainly brightened our spirits and we thank the Benefice Choir for providing such a fine musical backdrop. (Including a very adequate new Tenor)

2. Fabric

Having secured the Church from water ingress in 2022 we were then thwarted by drought. God moves in mysterious ways as does our Church building. Late in 2022 a different set of cracks appeared caused by the prolonged period of high temperatures and lack of moisture in our subsoil. The infamous clay resumed its shrinking and caused cracks to appear around the east window. As a result the keystone at the top of the window no longer needed to perform its' function and dislodged itself threatening to descend upon any passing parishioner. We have now put plans in place and with some judicious applications to Grant givers, thanks to our Treasurer Clive Johnson and the Friends of Lois Weedon Church we have raised enough money and work is due to start anytime now. We even managed to avoid the dreaded Faculty application after permission was given by the Archdeacon.

Our current focus is on the Chancel window and we are due our next Quinquennial Review this coming August. This will inevitably identify urgent repairs and there are signs of damp and deterioration which will require remedy. We will be looking at the feasibility of providing a more permanent and effective Servery within our means but the Toilet is likely to be some way off.

3. Mission

We are lucky to live in a rural community which by its very essence promotes a sense of belonging and tradition. Nothing gives a better sense than when we hold our Rogation Service. This last year was the turn of our Parish which was held at Lovell's farm Weston. The farming community provide a bedrock for our villages and are custodians of our landscape. The Church exists to serve its people by guiding and helping us all to lead a loving and fulfilled life. Unfortunately, there is no handy concise manual. So we do the best we can. Clearly, for the Church to survive it must appeal to those who could potentially help to support and continue its mission. I am convinced that my own somewhat reluctant willingness eventually to get involved started when I was a child. Regardless of whether you approve or disapprove of the role of Religious Organisations I see the story of Jesus Christ as the best children's story of all time. You couldn't make it up. And don't think it's just me, think of all the stories out there, whether in books, film or folklore. Can you think of any that doesn't have at its core the preference for good over evil.

Our Benefice and our own parish community have that in mind in all we try to do. We welcome the opportunity to help those who are in trouble. Our Pastoral care group under the guidance of Wiggy are here to help but we need to know who is in need.

4. Fundraising

Our fundraising activities continue to provide a vital source of income whether it is at a Benefice or Parish level. The highlights were the Barn Dance, with our own Caroline R's Tea party and Jill and Donna's Plant and Produce sale. Easyfundraising has given us a modest but welcome income but we recognise that people need a better understanding and 'coaching' on how to use it. The Benefice Quiz continues to provide entertainment and revenue not forgetting the 'Murder Mystery'.

We will be continuing holding regular coffee mornings again but with greater ambition. We hope to spread our net wider and see if we can attract people from outside our more parochial group. There are several of our supporters who may not be regular churchgoers but who have sympathy for our endeavours.

The popular Quiz is reaching its latest conclusive round having proved very popular and financially successful last year. Also the Benefice Barn Dance will once again take place at Manor Farm in June. Last year proved popular but we hope to encourage even more to join in especially in the lighter warmer nights.

The Benefice fundraisers have been a major contributor to the running costs of the Benefice, including Parish Share, relieving the pressure in the parishes.

5. Church Council

Our Church Council is now able to meet in more convivial and warmer surroundings. Roughly once a month we meet to discuss our Church matters. I am delighted that Sue Greenaway joined us together with Iris Gregory. Mike Streten has taken over the secretarial duties, a thankless task trying to sift the wheat from the chaff. Finally we also now have the guidance of our Rector Hugh White who brings a wider understanding of the challenges facing rural parishes and guidance on the mechanics of Church protocol.

1. Worship: Our average Sunday attendance has increased to 11 this year. We have enjoyed special services with many more in attendance. We particularly enjoyed our joint services with the chapel these were a Coronation Celebration, Remembrance, Carols by Candlelight and Mothering Sunday.

We don't have any children at normal Sunday services but enjoy welcoming five families to our quarterly Messy Church sessions. A joint church and chapel group also run a school lunch time club where we entertain up to 24 children – especially if food is involved!

We now have a regular Time To Pray on a Thursday morning. Otherwise our service pattern has remained the same with two communions a month, one morning prayer and Praise and Prayer where we have looked at topics such as St David, St Paul and the work of Charlie Mackesy as well as celebrating Pentecost, our Patronal festival and Palm Sunday.



2. SCC Syresham Church Council met in June, October, November, January & April.

We continue to support our school, plan fundraising and special services such as Harvest, discuss building works & finances and receive reports from our Friends and Trusts groups. Current members of the SCC are:

- **3. Building works**: We have been busy raising money for our church Steeple. Repairs will cost over £80,000. We now have enough to cover the cost, but some of this comes in the form of a loan. Unfortunately the builders are finding it difficult to source suitable shingles so it looks as though the work will not be done until the autumn. Other Quinquennial works have been completed but we will leave the final group until the steeple work is finished.
- **4. Church Helpers:** We are forever grateful to the church members who help us to run the church by cleaning, decorating with flowers, reading in services, leading intercessions, serving coffee, leading services, playing the organ, ringing bells, lighting candles, setting up for services and welcoming folk coming to worship it wouldn't work without you. It is wonderful to have welcomed two new members to the rotas this year. Also Nicola and David have done sterling work upgrading our children's area, coffee corner and church noticeboard.
- **5.** Churchyard Working Party: Our CWP of around 15 good folk have worked hard on the first Saturday of each month to improve and maintain the churchyard. We now have some wild areas and a bug hotel. The Parish Council handed responsibility for the new churchyard back to us so there is plenty to do. We are awaiting the removal of a large self-seeded sycamore tree once the tree surgeons finger has mended. We also thank our mowers who keep the grass around the church under control.
- **6. Friends of St James** The committee have arranged a Quiz, Walks, Pancake Lunch and the 200club this year alongside Christmas and summer parties. We are looking forward to a Safari supper in June. Membership has grown slightly and we have a new member on the Committee. They have pledged £4000 towards our Steeple Fund. We give grateful thanks to Antoinette and all the team.
- **7.Fundraising:** We enjoyed the Note-Ablity concert in July. Our Fete in September turned out to be the hottest day of the year, and the Christmas Fair on the coldest day. This meant our total fundraising raised less than £2000, which was very disappointing. We are joining with other village organizations in June for a Village Celebration, which will include the church fete. We hope this will result in better advertising and more footfall. We are falling short of paying our full parish share and need to find ways of increasing our regular giving and fund raising.
- **8. Trusts:** The Madge and Maud Payne trusts have continued to support us with our maintenance work. With the help of Brian Miller, our lead trustee, we have re-organized the investments to make clearer the difference between income, which we can use for church maintenance, and capital growth, which we cannot touch. The Hammond Trust enables us to deliver plants or hampers to folk at Christmas time and buy bibles and books for the school children.
- **9. The Bell Tower:** We enjoy having our Bells rung to welcome folk to special services. Many thanks to Andrew North for leading the tower also for doing a lot of cleaning with his trusty helpers. We look forward to celebrating the 400th birthday of some of our bells in June.
- **10. Our thanks:** To Paul Stothard, Rev John Roberts, Rev David Bell and Rev Will Adams for leading our services through the interregnum and to Rev Hugh as he leads us into the future.

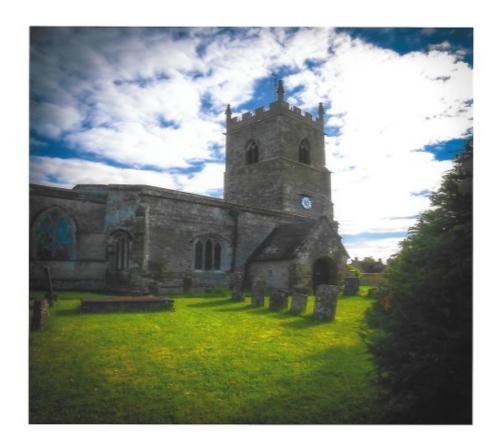

1. Churchwardens' Report

Our thanks are expressed to all members of the Wappenham Church Council during its second year of operation. Chaired by Edwin King, these included Sheena Warren, Peter Oliver, Philip Thompson, Jane Mordue, Anthony Tucker, Angus Wade, Michael Bath, Di Watts and Barbara Gundle. We were very sad to lose Di Watts in January 2024 after so many years of cheerful and dedicated service to the Church.

The parish's Church Councils continued to hold bank accounts and were responsible for fundraising and expenditure on fabric.

1.1 Building and repairs

Grass mowing had been reviewed, following the move to handover the closed churchyard and the need to find someone to mow the new graveyard. Thanks are expressed to Robert Tomkinson for kindly looking after the latter in recent years. A sit on mower was obtained. The mowing of the closed churchyard was put to contract whilst negotiations were ongoing with the Parish Council. Our gratitude also to all those who give their time to do the flower arrangements, clean the church, and fulfil numerous other jobs which ensure the church continues to have an attractive aspect. Our interest as owners in the repairs to the Village Hall roof by their committee was maintained by checking their insurance policy.

Quotations were sought to repair the boiler roof damaged the previous year by falling stone from the tower crenellation and final agreement from the insurers was needed. A way had been agreed to ensure that the weathercock, which was causing the flag pole to turn, would be stabilised.

1.2 Fabric

There have been no additions or removals from the Church other than the kind provision by a parishioner of pew seat cushions.

The Church continues to house equipment providing high speed broadband for the village and surrounding area.

1.3 Worship and attendance

The Church is open daily for services or private prayer and reflection. A regular pattern of services has been maintained including Holy Communion, Morning Prayer, Village Prayer and Praise and Breakfast Church. Attendance has remains steady by the usual congregation with broader community support at Christmas and Easter time.

We were delighted to welcome Revd Hugh White.

We thank the other members of the team for their ministry and pastoral support.

4. Funding

4.1 Expenditure

Donations: A total of £1,250 (2022 £726) as donated to charitable organisations from the general fund.

Benefice: £9,729 (2022 £9729) was paid to the Benefice in lieu of Parish share and Benefice expenses, and a Diocese certificate of thanks received, confirming this was 100% of that requested.

4.2 Income:

Collections from services totalled £3,329 (2022 £5,151). Regular covenanted giving was £9,822 (2022 £10,077).

5. Fund-raising

5.1 Church

Events raised a creditable £2,544 (2022 £2853) with events such as the ever popular Summer Fete and the Wappenham Dog Walk and Show which we organised, and the Wappenham Beer Festival, in which we participated, much enjoyed by everybody. Thanks are expressed to lead Angus Wade and everyone who helped.

5.2 The Friends of St Mary the Virgin Wappenham The Friends is a registered charity (number 1116889) established as a trust to enable fund raising and fund management for the maintenance, repair and restoration of the fabric, grounds, graves, graveyard boundary walls and gates of the Grade II* Church of St Mary the Virgin, Wappenham.

The Friends trustees are: Jane Mordue (Chair), Anthony Tucker (Secretary), Alastair Judge (Treasurer), Sheena Warren (Churchwarden), Edwin King (Churchwarden) and until January, Di Watts. The Friends were sad to note the passing of Di Watts in January 2024, a true servant of the Church, kind, supportive and still attending meetings on Zoom until very recently.

5.3 Friends' Treasurer's Report

The Friends' funds stand at £6,756 (2022 £5361) of which £750 is earmarked for the WC.

Income in 2023 was £1,260 (2022 £1,405) and outgoings were £60 – bank fees - (2022 £30). There is also outstanding Gift Aid awaited.

In recent years, as the Church had undertaken its own fund-raising events, the Friends has focussed on supporting these and receiving regular donations. It was likely that funds for fabric works would in the future be deposited in the Church designated restricted fabric account. This would be a saving on administration including bank charges.

5.4 Works and Faculties

No major works in 2023. Thanks are expressed to all the kind members of the Friends and our supporters.

Details of the recipients are confidential but are available to any person – in confidence – nominated by the Parish Council. The Chairman confirms that all awards and gifts were safely received.

The Distribution Committee is led by Jenny Spillett. Other committee members are Barbara Gundle, Hilary Wickham and Philip King . The Committee was also joined *ex officio* by the Rev Hugh White.

We made 8 small gifts to a number of residents who it was felt had suffered a period of distress for whatever cause, (perhaps illness, losing a job or family issues) at Christmas. In January we received a request for financial support and have duly paid out £738.60 in two amounts in January and March.

The total amount distributed was £1,038.28.

The charity currently has £4,815.16 in reserve. The Distribution Committee received two contributions from the Trustees totalling £2,000.

The purpose of the charity is to help people in Wappenham who find themselves distressed for whatever reason, and the Trustees would therefore be happy to consider requests, perhaps of a practical nature, during the course of the year, as well as at Christmas time. They would welcome the help of the Wappenham Church Council and the Parish Council in this respect.

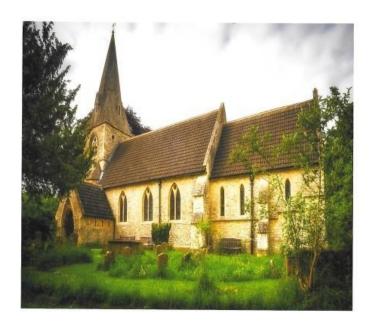
8. Bell ringers

The Charities: Background

Income derives from the rental of a number of small parcels of land owned by the charities and some investments

Whitfield Forest Allotment

Origin dates to 1826 and was formed to replace the rights of the villagers to collect firewood from common land after the acts of enclosure. Historically this was interpreted to mean to assist those in need with the cost of fuel. More recently it is used to buy small gifts for those in the village that have had a difficult year.

Whitfield Old Church School

Origin dates to 1764 and was formed to pay for a schoolmaster to instruct the children in reading writing etc and assist with books etc. This was updated following the closure of the school to enable books or clothes to be purchased for the children of the parish. In previous years children over the age of 4 have been identified and either a Bible or other educational book has been presented to them as a one-off gift. As records are not complete and we rely on members knowledge of the village, we may well have missed some children. Please advise us if you know of eligible children that have not received this small token/ acknowledgement.

Whitfield Listers Charity

Origin dates to 1708 and was formed for apprenticing children under the age of 21 or for their advancement. As there are a declining number of apprenticeships these days, this has been interpreted to mean the provision of sums of money to help children with the purchase of books, lessons, coaching sessions or school trips if it is for their "advancement".

For this award we would ask individuals to approach a member of the committee with specific requests
